A certifier, for example, a site supervisor, must always act in compliance with the principle of good faith, pursuant to article 1375 of the Italian Civil Code as regards the parties.. Generally, the parties are not bound by certificates, unless it is provided by the contract. However, if the certifier acts on behalf of one of the parties, the certificate becomes binding for that party.

ITALIAN INHERITANCE LAW Legal heirs. Where a person dies without a valid Will -intestate-, the Italian succession law indicates who will inherit the estate and how much each beneficiary will inherit.
